The current expansion program is estimated at \$48M to add 224,000 sq. ft. of exhibit space comprised of three new galleries including a space gallery presenting the Air Force role in space, a presidential aircraft gallery displaying 'Air Force One' aircraft, and a global reach gallery showing the important role of airlift in military operations. The United States government requires 100% of the cost of construction prior to obligating a project. The Air Force Museum Foundation donated an initial \$750,000 in 2010 for design and preliminary testing and \$11,614 for modular furniture upgrades in 2011. The Air Force Museum Foundation has an additional \$35M available for the project and hired a new full-time Chief Development Officer to
